## Assignments

### Reading Assignments

### Writing Assignments

A series of research essays or publications. Length to be determined by the scope and type of independent study.  
For example, produce a 5-page essay comparing and contrasting basic practices in community policing and procedural justice.

### Other Assignments

Students will be required to complete assignments outside of class. Research, projects and performance activities will be completed out of class.  
For example, while working with a local criminal justice agency, create a program or complete a research project specific to the needs of that agency.
